## HISTORY

The Unforgettables Foundation is a 501(c)(3) non-profit organization founded by Timothy Evans in 1999. During a decade of clinical ministry to children and their families, Evans assisted families with the many crises surrounding the death of a child not the least of which are the crushing financial burdens experienced by families with limited resources.

Assisted by Inland Empire educators, medical professionals, social workers, CPAs, attorneys, bankers, morticians and others, Evans created The Unforgettables Foundation. Paramount among aspects of the Foundation's mission is to assist low-income families provide a dignified, appropriate burial for their children who have passed away.

## Mission

The mission of The Unforgettables Foundation is to:

- Enable low- income families to give their children a dignified burial.
- Empower communities to memorialize children who have died.
- Educate parents and children's caregivers to confront, control and conquer the primary risks to our children's health and wholeness.
- Encourage communities to recognize the financial trauma which is often associated with the death of a child.

## BURIAL ASSISTANCE

For many families, the anguish and heartbreak of a child's death is accompanied by the additional burden of financial incapacity. The simple truth is that many families are unable to afford a dignified, respectful burial for their beloved child. The Unforgettables Foundation provides financial assistance to those families with limited resources to help offset the costs of final arrangements.

The Foundation's help is granted to families across the Riverside, San Bernardino and Orange Counties in California, also Southern Nevada. Requests for aid come from hospitals, schools, places of worship, social service agencies, and families themselves. Since the incorporation of the Foundation in 2000, over 5,000 families have been assisted in 100 cities in Southern California and Nevada.
